MINUTES NORTHEAST OHIO REGIONAL SEWER DISTRICT BOARD OF TRUSTEES MEETING APRIL 7, 2016

Meeting of the Board of Trustees of the Northeast Ohio Regional Sewer District was called to order at 12:30 p.m. by Darnell Brown.

The Secretary informed the President that a quorum was in attendance.

II. Approval of Minutes

MOTION – Mayor Bacci moved and Mayor DeGeeter seconded to approve the minutes of the March 17, 2016, Board Meeting. Without objection, the motion carried unanimously.

III. Public Session

Chief Executive Officer (CEO) Ciaccia advised that no one signed up to speak about a specific agenda topic.

IV. Chief Executive Officer's Report

CEO Ciaccia began his report with the proposed schedule for rolling out the results of the rate study determinations for years 2017 through 2021. Yesterday, a presentation was made to senior staff and the study consultant regarding the outcomes of the rate analysis. They discussed some of the assumptions and goals from a financial standpoint. Staff is putting that information into a final draft report. The draft will be delivered to Chief Financial Officer (CFO) Jennifer Demmerle on April 11.

The Board will receive the final draft on April 20 in advance of the Special Board Meeting scheduled for April 26 for a presentation only. No Board action will be recommended that day and staff is seeking Board input.

District staff is also scheduled to meet with Cleveland Mayor Frank Jackson on April 29 to review the report. CEO Ciaccia stated that District staff intends to meet with all the appointing authorities of the Board.

Subsequent meetings are scheduled with various media outlets, including Crain's on May 2, The Plain Dealer Editorial Board and the Suburban Council of Governments on May 3. The District will also conduct several road shows, including April 19 at Nordonia High School, May 25 at Tri-C West. Tri-C East on June 4 and Tri-C Metro on June 8.

The Board is expected to be presented with any further information and potential action during its meeting on June 16th.

CEO Ciaccia noted that a meeting has yet to be scheduled with Cuyahoga County Executive Armond Budish and the Akron Beacon Journal.

Moving to community cost-share stormwater agreements, CEO Ciaccia informed the Board that 33 member communities have signed such agreements and six more are in process -- including the City of Cleveland. There are 17 communities that have not yet taken action.

Concluding his report, CEO Ciaccia welcomed Eric Luckage, who is the new Chief Legal Officer & General Counsel.

Mr. Brown requested an elaboration regarding the Superior Stones Canal Project. James Bunsey, Director of Engineering & Construction, advised that this is a combination of two projects that help the District meet consent decree control measures 9, 10 and 11. Specifically, they are repairing and replacing the Superior Pump Station -- located near Heritage Park -- and the smaller Stones Levee along Stones Levee and West 3rd Street. The result of the project would reduce three combined sewer overflows (CSOs). The project relies heavily on separation upstream and putting in a fairly large retention basin for storage.

Mr. Brown asked for clarification regarding the term "separation." Mr. Bunsey explained that there is sewer separation upstream of regulators E-24 and E-28 to reduce the flows. The project will remove the flow from the CSO and result in a larger capacity pump station. He further stated that staff is in coordination with the Republican National Convention to make sure construction does not begin until August 1.

Mr. Brown requested an explanation. CEO Ciaccia advised that there has been controversy over the ownership of the 72-inch sewer line on Ridge Road between Cuyahoga County and City of Brooklyn. The sewer is experiencing major failures.

The line is an intercommunity sewer that runs through Cleveland, taking a lot of flow from Cleveland through Brooklyn. Recently the District took over ownership of the line to make the proper emergency and long-term repairs and to end the dispute so there are no additional occurrences. There is an immediate emergency situation that needs a substantial fix.

Engineering staff received quotes from four contractors currently working on District jobs to perform the repairs and Independence Excava ting was the lowest quote. The vendor also happens to be working on the Chevrolet Boulevard job. Staff is requesting approval of the low bid and to modify the Chevy Boulevard contract to add this project into the scope of their contract.
