MINUTES NORTHEAST OHIO REGIONAL SEWER DISTRICT BOARD OF TRUSTEES MEETING JANUARY 20, 2022

A Regular Meeting of the Board of Trustees of the Northeast Ohio Regional Sewer District (NEORSD) was called to order at 12:30 p.m. by Ronald Sulik.

I. <u>Roll Call</u>

The Secretary informed the Vice President that a quorum was in attendance.

II. Approval of Minutes

MOTION - Mayor Bacci moved, and Ms. Dumas seconded to approve the Minutes of the January 6, 2022 Board Meeting. Without objection, the motion carried unanimously.

III. Public Session

There were no items.

IV. Chief Executive Officer's Report

Kyle Dreyfuss-Wells, Chief Executive Officer, provided an update regarding NEORSD's ongoing COVID-19 pandemic response and informed the Board that NEORSD staff has 5 active COVID-19 cases, and 4 employees with COVID-19-like symptoms awaiting test results. There is 1 employee remaining at home because a member of their household tested positive. There has been a total of 203 employees with confirmed diagnoses since the beginning of the pandemic, 198 of whom have recovered and returned to work. NEORSD continues to monitor the numbers as it has throughout the pandemic. The numbers continue to decline from the time of the last Board meeting.

Ms. Dreyfuss-Wells advised the Board that Scott Broski, Superintendent of Environmental Services, was recently elected Chair of the Cuyahoga County Local Emergency Planning Committee. The Committee is comprised of people from around the county responsible for response to incidents involving hazardous materials. Each local Emergency Planning District across the country is required to have such a committee under the Emergency Planning and Community Right to Know Act to provide information to residents as well as develop and implement Cuyahoga County's Hazardous Materials Plan. Mr. Broski has represented NEORSD on the committee since 2014. Ms. Dreyfuss-Wells offered congratulations to Mr. Broski for taking this leadership role.

Ms. Dreyfuss-Wells offered appreciation and kudos to the members of Operation and Maintenance and Security teams for their work on Monday, January 17 and Tuesday, January 18, to continue operations to protect public health and water quality, keeping all facilities running despite the severe weather conditions.

Mr. Oleksa was instrumental in bringing a new level of professionalism to the committee with the perspective and breadth of experience gained from his work in internal audit, finance and regulatory affairs at publicly traded companies."

Regarding Resolution No. 28-22, Mr. Sulik asked Ken Duplay, Chief Financial Officer, to explain the process of contracting with Ciuni & Panichi, Inc.

Mr. Duplay explained that for eight years though the 2019 audit, NEORSD's audits had been performed by an independent public accounting firm. For 2020, the Ohio Auditor of State chose to perform the audit themselves. Upon completion of the audit, the Auditor of State informed NEORSD that it could contract with an independent accounting firm for the next five-year period. NEORSD worked with the Auditor of State to put together a Request for Proposals (RFP).

Four accounting firms provided proposals, which were reviewed and graded by the Auditor of State. NEORSD also had an opportunity to grade the firms and requested that the Auditor of State approve Ciuni & Panichi, Inc., which had previously served as NEORSD's independent public accounting firm, to serve for the next five-year term, with an option at the conclusion of the five-year term to extend the contract for an additional five-year period.

Mr. Sulik requested additional information regarding the project associated with Resolution Number 32-22.

Doug Gabriel, Deputy Director of Engineering and Construction, explained that the Shoreline Consolidation Sewer is part of Control Measure 7 of the Consent Decree and is the sister project to the Shoreline Storage Tunnel, which began construction last summer.

The Shoreline Consolidation Sewer consists of approximately 5,100 feet of 72-inch micro tunnel spanning from East 40th Street to the Shoreline Storage Tunnel Shaft No. 3 at East 55th Street. The project also includes eight regulator modifications.

Kokosing Industrial, Inc. was the low bidder of the three bids received for the project. Their bid was 7% higher than the engineer's estimate of \$51.5 million. NEORSD received a number of questions during the bidding process regarding the connections to the Easterly Interceptor and supply chain issues with the cured-in-place-pipe (CIPP) lining materials and is likely the reason that the projected costs are higher than in the past.

Kokosing Industrial's bid is low on the Business Opportunity Program (BOP) commitment and NEORSD will work with them throughout the project to bolster those numbers.
