# MINUTES NORTHEAST OHIO REGIONAL SEWER DISTRICT BOARD OF TRUSTEES MEETING December 6, 2018

A Regular Meeting of the Board of Trustees of the Northeast Ohio Regional Sewer District was called to order at 12:30 p.m. by Darnell Brown.

# I. Roll Call

The Secretary informed the President that a quorum was in attendance.

# II. Approval of Minutes

MOTION – Mayor Bacci moved and Ms. Dumas seconded to approve the minutes of the November 15, 2018, Board Meeting. Without objection, the motion carried unanimously.

### III. Public Session

There were no items.

# IV. Chief Executive Officer's Report

CEO Dreyfuss-Wells began by giving an update on the water line break that occurred at the Environmental and Maintenance Services Center, EMSC on December 5, 2018. CEO Dreyfuss-Wells introduced Thomas Madej, Deputy Director of Operation & Maintenance, to provide the members of the Board with an update.

Mr. Madej presented the Board with photographs that showed a timeline of the sequence of events along with the damage that happened during the water line break. The water main break was isolated in the northwest corner of the EMSC Facility. The water damage that occurred was mostly at the lower levels of the building which are all concrete surfaces. The water line coming into the building from the northwest corner had to be isolated and because of that, the whole complex was shut down without water. It took about two hours to isolate the water coming into the building. The EMSC staff was unsure which line to isolate since there is also a parallel line that supplies fire protection in that same complex. There were also some valve vaults full of water which needed to

be dewatered before getting to the valve. Mr. Madej explained that an Incident Command Team was created consisting of a planning person, operations person, logistics person, and an incident commander. Through this Incident Command team and the District Administration team, communication was given to President Brown per the District's bylaws.

There was bottled water available for EMSC staff as well as portable restrooms and hand sanitizing locations. There was also a shuttle available to Southerly for employees that wanted to shower or use the restrooms there. Mr. Madej explained that after speaking with senior staff, the decision was made to send non-essential staff home. During that time the emergency work authorization was approved for Shook Construction to mobilize as well as clean up services through SERVPRO.

Mr. Brown thanked Mr. Madej for his briefing but expressed concerns on being more efficient if an incident like this happens again and how to address any electrical issues that may arise. As well as how to ensure that "unsafe" water is not being used.

Mr. Madej explained that there were some electrical issues that came up like the two conduits that had water coming through them but assured that those electrical issues have been resolved. CEO Dreyfuss-Wells noted that the drinking water will be tested before it's once again potable so there will be bottled water until Monday for the employees at EMSC and introduced Scott Broski, Superintendent of Environmental Services to speak more on how to ensure the water is properly tested. Mr. Broski explained that there will be a number of samples collected that will be tested for chlorine residual and coliform bacteria, which is a 24-hour test. There are signs posted and there is really no water pressure when trying to use a drinking fountain but once the test comes back, the water will be at full potable consumption usage.

Next, CEO Dreyfuss-Wells spoke on the Clean Water Works Journal. The edition covers the history of the Cuyahoga and the formation of the Sewer District, and the 50<sup>th</sup> anniversary of the last time the river burned. This technical journal has a lot on the District's projects which was put together by Mike Uva and its one of the many resources of the River Reborn campaign. CEO Dreyfuss-Wells closed by announcing the Cleveland Rocks Award received by the CCR Department from the Public Relations Society of America.

**MOTION** – Moved by Mayor Stefanik and Mayor Bacci seconded to adopt Resolution Nos. 402-18 and 403-18. After the following discussion, without objection, the motion carried unanimously.

The Board requested an explanation for Resolution No. 403-18. Devona Marshall, Director of Engineering and Construction, explained that as part of this project the District will be replacing

equipment much of which was installed in the 1970s and addressing safety issues within the two pump stations. Ms. Marshall explained that the progressive design-build delivery was selected for the project because the means and methods of the contractor will drive design and construction especially with the replacement of the MCCs.

Ms. Marshall also explained that the one step or the fixed price design-build delivery, which only requires the project to be presented to the Board once and awards both the design and construction, is appropriate where little to no design is required.

Mr. Brown requested an explanation for Resolution No. 404-18. Kenneth Duplay, Chief Financial Officer, explained that this will be the first loan of 2019 awarded by OWDA in January. The interest rate would be in the mid 2 percent range versus 3 to 4 percent on the bonds. The dollar savings will be presented in total in the year-end-review summary of the 2018 loan activity which will allow for a comparison of what it would have looked like if it would have been done via a bond issue instead.
